## **Australian Government - Disaster Recovery Allowance**

This allowance provides a short term support payment to assist people whose income has been affected as a direct result of the bushfires.

## **NSW Government - Disaster Relief Grants**

Grants are available for eligible individuals and families whose homes and essential household contents have been damaged or destroyed by a natural disaster.

To be eligible for this grant you must:

- be a low-income earner and meet an income assets test
- demonstrate that the affected home is your principal place of residence
- not be covered by insurance
- demonstrate that the damage was caused by the disaster
- lodge the application within four months of the disaster occurring

## **Australian Tax Office**

## Telstra disaster relief

Telstra customers who have suffered severe damage or loss of their premises can access:

Free call diversion from the customer's Telstra fixed phone service to another Australian fixed or mobile service of their choice, regardless of the carrier. This offer is applicable for a maximum period of 6 months from the date of the fire.

In addition, Telstra will apply a one off credit to the value of \$500 inc. GST to the customer's Telstra fixed phone account to help cover the costs of the following, if required:

- Connection of a Telstra fixed phone service at one temporary residence
- Re-connection of a Telstra fixed phone service at the customer's original permanent premises.

## Replacing personal documents

Service NSW can help replace many of your personal documents free of charge if they were damaged or destroyed.

This includes birth certificates, marriage certificates, licences and number plates.

# Housing assistance

The NSW Government has launched the Bushfire Housing Assistance Service to support people who are temporarily or permanently displaced due to the recent NSW bushfires.

If your home has been lost or significantly damaged, you can access the Bushfire Housing Assistance Service that will help you with:

- emergency temporary accommodation
- assistance with a private rental bond and advance rent costs
- sourcing accommodation options from the private rental and short-term housing sector.

The service also helps people source rental housing in their local communities or areas where they have family and local networks.

People impacted by the fires can access the new service by:

### If you are insured:

Take photos or video of damage to your property and possessions as evidence for your claim.

If you have clearance from your insurer and evidence for your claim, you can start cleaning up.

## Free title searches and plan images

NSW Land Registry Services (NSW LRS) is helping landholders affected by the recent NSW bushfires by providing title searches and plan images of their property free of charge.

Property searches and plans can assist landholders with insurance claims and development applications to council, as well as provide peace of mind regarding land ownership following natural disasters.

If you have been affected by the recent bushfires and would benefit from access to land and property information from the land titles register, please call the NSW LRS Contact Centre on 1300 396 076 and we can discuss how best to assist you.

NSW LRS operates the land titles register on behalf of the NSW Government, as well as the General Register of Deeds and the Water Access Licence Register. These registers hold essential information about properties across the state, including about ownership, restrictions on use, title boundaries, plans, and water access and use. Information held on these registers is available for landowners to view through land and property information searches.

This is of particular relevance to landholders who immediately border national parks and nature reserves affected by the recent fires. NPWS is offering to purchase and supply an agreed quantity of fencing materials to reconstruct boundary fences.

This offer applies to the replacement or repair of pre-existing boundary fences only.

# **Liquor & Gaming NSW, support for licensees**

Liquor & Gaming NSW is providing the following support to licensees who have been affected by the bushfires:

- extra assistance for liquor licence applications

- financial hardship provisions for annual liquor licence fees

If your licensed premises is unable to trade for more than 6 weeks, please notify the Independent Liquor & Gaming Authority by submitting a Cease to trade notice.

# Lost or destroyed licences, permits, certificates

# **Fair Trading**

Free replacement of the following licences, permits or certificates that have been destroyed or lost during the bushfires:

- home building: contractor, qualified supervisor, tradesperson
- property and real estate
- motor vehicle dealer or repairers
- pawnbrokers and second-hand dealers
- tattoo parlour or tattooist
- owner-builder
- tow truck.

To apply for a replacement card use the <u>Application for a Duplicate Licence</u>, <u>Certificate or Permit – PDF</u>, and note on the form that the reason for the card replacement is that it was lost in the bushfires. Also provide the home address if it is different to your nominated address.

Free Owner-Builder Permit where you opt to rebuild or repair your home damaged or destroyed by a bushfire (all other standard requirements and associated development approvals apply).

# **Animal welfare**

# Clean up

## **General advice**

- Do not enter your property until you are advised that it is safe to do so by emergency services, utilities companies or local council.
- Electrical hazards could exist such as live power lines that may be down or active solar panels.
- Buildings and other structures may be unstable to enter or walk over.
- Sewerage services may be disrupted causing health risks.
- Be aware that hot, smouldering coals and other potentially hazardous materials may be hidden under the rubble.
- Building rubble should not be buried as it may contain hazardous materials.
- Don't spread ash around your property, particularly if asbestos materials were used in your home or other structures, or CCA-treated timber was burnt.
- Moisten the ash with water to minimise dust and keep damp but do not use high pressure water sprays.

#### Hazard identification notices

A hazard identification notice indicates dangers like electrical risks, falling branches or asbestos may have been identified at your property.

Only return home when you have been given approval. When you do, even if there is no sign, there may still be hazards on your property.

Please ensure you wear a P2 face mask, which can filter out very fine particles from the air.

If the Hazard Identification Notice indicates asbestos is suspected on your property, you can get further information from the Public Works Advisory.

## Clean up assistance

The NSW Government is coordinating the clean-up of NSW residences and businesses impacted by the NSW bushfires. This includes both insured and uninsured properties.

Public Works Advisory (PWA), in consultation with property owners, is leading the cleanup effort with insurers, local government and contractors, to ensure that properties are efficiently and safely cleared.

The clean-up of bushfire-impacted properties may include:

- containment and removal of asbestos and other contaminated materials released as a result of bushfire
- removal of all dangerous debris including destroyed material and hazard trees
- removal of concrete slab foundations.

Testing will be carried out on all properties to ensure communities already impacted by fire are not exposed to contamination, and workers are not exposed to any hazardous materials. Work will begin once firegrounds are declared safe by the Rural Fire Service.

Note: The cost of clearing properties will not be deducted from the funds available under insurance policies.

Please register with your details. The government is working through the eligibility criteria and will contact you when the specifics are finalised. If you are insured, also speak with your insurer.

#### Fire retardant contamination

Retardants dropped from the air to suppress / slow fires may have landed on some properties. This type of retardant is basically a fertiliser (a mix of ammonium and diammonium sulphate and ammonium phosphate). Coloured foam will need to be flushed from roofs and water sources.

To prevent any retardant or ash getting into water tanks, residents should disconnect their downpipe/s from water tank/s, so that the first flush (either rain or washing) does not wash anything from the roof into tanks.

### Using rainwater after a fire

## Health

When smoky, avoid vigorous exercise outside, especially if you have asthma, diabetes, heart disease or a breathing related condition.

If you have an air conditioner at home, turn it on and use it in a recirculate mode.

If you are experiencing any adverse reactions to the dust or smoke, such as shortness of breath, prolonged coughing or wheezing, seek medical advice.

Tank water could have become contaminated from debris, retardant, ash or dead animals. If the water tastes, looks or smells unusual, do not drink it or give it to animals.

All foods that have been fire-damaged or affected by heat should be thrown out - including refrigerated foods if there has been a power outage during the fire.
